### Fund Summary

The Themes US Cash Flow Champions ETF (LGCF) seeks to track the Solactive US Cash Flow Champions Index (SOLUCFCT), which identifies the top 75 large/mid capitalization companies with the highest 3 years of positive cash flow yield. LGCF seeks to provide investment results that correspond generally to the price and yield performance, before fees and expenses, of the SOLUCFCT Index.

### Potential Benefits

- **Cash is King:** Generally, companies with high cash flows are more resilient in times of duress given their self-sufficiency to fund ongoing operations.
- **Cost of Capital:** As the cost of capital rises with tighter monetary policy, company cash reserves have rapidly depleted relative to debt since 2021; companies with high cash flows are generally better positioned to service existing debts and less reliant on external financing, which has become more expensive.<sup>1</sup>
- **Strength in Stability:** 57% of medium cap firms and 40% of large cap firms have interest coverage ratios less than 4, reflecting a greater risk of default amongst most companies; companies with high cash flows are generally less susceptible to shocks in financing and typically have higher interest rate coverage ratios.<sup>2</sup>
