Potential Benefits

- **Cash is King:** Generally, companies with high cash flows are more resilient in times of duress given their self-sufficiency to fund ongoing operations.
- **Cost of Capital:** As the cost of capital rises with tighter monetary policy, company cash reserves have rapidly depleted relative to debt since 2021; companies with high cash flows are generally better positioned to service existing debts and less reliant on external financing, which has become more expensive.¹
- Strength in Stability: 80% of small cap firms have interest coverage ratios less than 4, reflecting a greater risk of default amongst most companies; companies with high cash flows are generally less susceptible to shocks in financing and typically have higher interest rate coverage ratios.²
