The Themes Gold Miners ETF (AUMI) seeks to track the Solactive Global Pure Gold Miners Index (SOLGLPGM), which identifies the largest 30 companies by market capitalization that derive their revenues from gold mining. AUMI seeks to provide investment results that correspond generally to the price and yield performance, before fees and expenses, of the SOLGLPGM Index.

Potential Benefits

- BANK BULLION:** Global central banks continue to drive demand for gold production; at 1,082 metric tons in 2022, gold demanded by central banks has risen over 936% over the past decade and is at an all-time high. (1Source: Bloomberg, Metal Focus Data Ltd. As of 30 November 2023)
- MARGINS:** With current prices above \$2,000/ounce, the price of gold remains above the average all-in sustaining cost of \$1,345/ounce for gold miners. (2Source: S&P Global as of 31 December 2023)
- VALUATION:** With a price-to-book ratio of 1.63, gold miners remain more attractively valued relative to the broader market as measured by the S&P 500 Index, which has a price-to-book ratio of 4.25. (3Source: Bloomberg as of 30 November 2023)
