The Themes Natural Monopoly ETF (CZAR) seeks to track the Solactive Natural Monopoly Index (SOLNMONN), which identifies the top 5 companies within 19 different sectors that have:High Sales, Stable Profitability, Stable Return on Equity, Operational Efficiency, Reinvestment of Profits, CZAR seeks to provide investment results that correspond generally to the price and yield performance, before fees and expenses, of the SOLNMONN Index.

Potential Benefits

- COMPETITION CORRELATION: Generally, as competition rises, profitability falls; firms that have natural monopolies within their respective markets tend to be more profitable than firms that face greater competition
- POWER IN PROFITABILITY: Economic profits are overwhelmingly concentrated within the top quintile of global firms, with the majority of firms making little or no economic profit. (1Source: McKinsey & Company as of 30 November 2023)
