The Themes US Small Cap Cash Flow Champions ETF (SMCF) seeks to track the Solactive US Small Cap $Cash\ Flow\ Champions\ Index\ (SOLSUCCT),\ which\ identifies\ the\ top\ 75\ small\ capitalization\ companies\ with$ the highest 3 years of positive cash flow yield.SMCF seeks to provide investment results that correspond generally to the price and yield performance, before fees and expenses, of the SOLSUCCT Index.

Potential Benefits

- CASH IS KING: Generally, companies with high cash flows are more resilient in times of duress given their self-sufficiency to fund ongoing operations.
- COST OF CAPITAL: As the cost of capital rises with tighter monetary policy, company cash reserves have rapidly depleted relative to debt since 2021; companies with high cash flows are generally better positioned to service existing debts and less reliant on external financing, which has become more expensive. - STRENGTH IN STABILITY: 80% of small cap firms have interest coverage ratios less than 4, reflecting a greater risk of default amongst most companies; companies with high cash flows are generally less susceptible to shocks in financing and typically have higher interest rate coverage ratios. 
